Council of Leaders Minutes*

Update By Dean Irwin

There was a miscommunication last year regarding the use of funds from the School Administration between the SBA and the School Administration. The school normally uses the leftover money originally allocated to LSO's to cover the cost of Barristers. Last year the SBA used their fundraising account to cover the cost of Barristers in the hopes that the money in the Ad Hoc fund would roll over to fund community service events and SCU Eats. This year's SBA has petitioned to have the funds rolled over from last year. The school will get back to us regarding their decision.

Proposal for Changes to the Constitution

There is a proposal to amend the Constitution Article 10 Section 3: Funding of Association Organizations and then enforce the new changes next semester. Currently if an LSO does not schedule at least 25% of their general meetings or activities after 5:00 PM the Finance Committee and the BOG should not approve that LSO's funding requests. However, this provision has not been enforced.

The idea is to change the language to require the LSO's to include the Part-Timers and if they do not then they may be in danger of having their funding pulled. The Legislative Committee will be holding meetings regarding the various proposals so that all interested parties may have an opportunity to voice their opinions and concerns.

Iris is the Voting Rights Organizer at the Asian American Legal Defense and Education Fund (AALDEF). She was responsible for coordinating AALDEF's Asian American Exit Poll for the 2016 Presidential Election, including securing co-sponsors, recruiting volunteers, and compiling the resulting report. She also coordinates AALDEF's weekly voter registration efforts at the Southern District of New York courthouse. Iris is currently the Chairperson of the Board of Directors of Pilipino American Unity for Progress (UniPro), where she has organized several conferences for Pilipino American students and young professionals, facilitated workshops across the country, and collaborated with community leaders in San Diego, Seattle, Chicago, and Houston to build new UniPro chapters there. For this work, she received the Outstanding Young Professional award from the Pan American Concerned Citizens Action League (PACCAL) in 2015 and she was a Queens Fellow in 2015-2016. 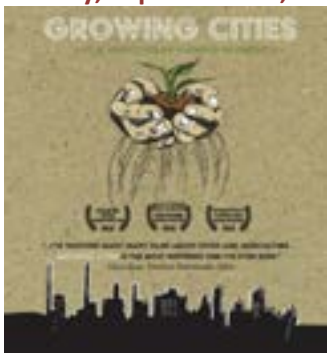
