	3/27 - 4/2	SUM	<ul style="list-style-type: none"> <li>▶ Check the Summer Schedule on the Law Student Services web page. Finalize your schedule choices. Have a few back-up schedules prepared.</li> <li>▶ 6 units is considered full time in summer. 8 units is the limit. You need 3 units in order to qualify for summer financial aid.</li> <li>▶ Read through the Pink Book for advice and information on course selection.</li> <li>▶ Make sure you can access eCampus. To use eCampus, go to <a href="https://scu.edu/login/">https://scu.edu/login/</a> and click on "eCampus". You will need your Campus login and password. Your login is the capital letter "W" and the last seven digits of your student ID number. If you can't remember your password, click on the "Forgot my Password" link on the eCampus main page.</li> <li>▶ Check eCampus to ensure that you don't have any holds on your records. The system <b>will not let you register</b> if you have holds.</li> <li>▶ Log on to eCampus and find your appointment day and time. Make sure you verify your schedule once you are finished registering. <i>Make sure you registered for the classes you think you did!</i> It is very important to "View your Schedule" each time you add or change your schedule to confirm that your registration transaction was completed accurately.</li> <li>3. <b>Please do not use the Swap Class feature.</b></li> <li>4. Wait List: When you determine that a class is full, click on the "Wait List" option and follow the prompts.</li> <li>5. Those students listed as "Eligible to Enroll" will need to add the class by the deadline listed on the wait list. <b>Students who do not add by the deadline will be dropped from the list</b> and the next group of students will become eligible. To register from the wait list, students must add the class on Ecampus by 11:59 p.m. on the date indicated.</p>
5/21	SUM		<p>► To avoid a \$100 late payment fee, your <b>payment must be made</b> on or before this date. 7/21	FALL		<p>To avoid a \$100 late payment fee, your <b>payment must be made</b> on or before this date. Those students listed as eligible to enroll will need to add the class by the deadline listed on the wait list. <b>Students who do not add by the deadline will be dropped from the list</b> and the next group of students will become eligible. To register from the wait list, students must add the class on Ecampus by 11:59 p.m. on the date indicated.</p>
8/14	FALL		<p>School starts. Registration from the wait list continues through Thursday, 8/17. Follow the directions above. Add/Drops allowed through Friday. To add and drop classes, use the eCampus system. NOTE: SATURDAY CLASSES START THE 19<sup>th</sup>!</p>
8/18	FALL		<p>Any seats remaining in wait listed classes will be opened at 8:30 am. These seats are available on a first-come, first-served basis through eCampus. The wait list no longer applies after this date.</p>
