**Guidelines**

- Santa Clara University School of Law students working full-time in qualifying public interest and social justice law positions may apply for a Summer Grant.
- The grant applications are due by noon on **Friday, March 15, 2013**, at the Center for Social Justice and Public Service, 3<sup>rd</sup> Floor Bannan Hall.
- Funding is for public interest and social justice work done during the Summer 2013.
- The amount of the award depends on applicant eligibility and the funds available during any given grant year.
- If the amount of applications exceeds the amount of funds available, funding priority may be directed to applicants working for non-profit 501(c)(3) tax-exempt organizations over for profit organizations and government agencies.
