

At our law school's first-ever Breaking Bread dinner, our fantastic alumni and newest students did more than share a meal, they brought new life to storied traditions with deep professional and spiritual roots. They would break bread together as a way of teaching, mentoring, and shaping professional identity. The inns of court in our area, including the honorable William A. Ingram American Inn of Court in Santa Clara County, carry out this tradition to help new lawyers along their way, and often do it by "breaking bread."

It's an act of solidarity with all communities who survived on bread as they fled oppression, including Indigenous People for whom the sharing of fry bread has become a celebration of freedom and community. Living out this vital Santa Clara Law mission of service to others, more than 50 of our incoming, transfer, and continuing students worked hard together over this past weekend to prepare sustenance packages for veterans and the most vulnerable members of our community. To all of our extraordinary students, we offer our profound gratitude for granting us the privilege of serving you as Dean, administrators, faculty, and staff.

Last year, we adopted a theme of Rising Together to illustrate our collective ascension from the depths of the pandemic along with our shared aspirations to grow in our understanding of one another as a community committed to working for a more just, humane, and sustainable world.
